#### 16.1 South End Development FOIP S.25

Councillor Harris moved that Council approve Development Permit 124124-22-D0019 subject to the following conditions:

- a. All development must be in accordance with the approved site plan. Any future development or change in approved plans shall require a new permit application.
- b. A sound attenuation barrier shall be provided and maintained between the commercial use and the adjacent Residential District. All details of the barrier, including its size, width, and components, shall be to the satisfaction of the Development Authority.
- c. The Developer shall submit a Landscape Plan prepared by a registered Landscape Architect for approval prior to construction. Landscaping shall be completed in accordance with the landscaping plan within one (1) year of completion of the development.
- d. Landscaping is required to screen all loading bays, waste and recycling areas, and outdoor storage from public view. This may include hedging, planting or a combination of walls or fencing with landscaping. All loading and off-loading shall be done within the property.
- e. All parking areas shall be clearly marked, hard surfaced, landscaped, adequately lit with lighting directed away from adjacent sites, adequately graded, and drained to direct all stormwater run-off away from adjacent properties.
- f. Any lighting proposed to illuminate areas in any district shall be located and arranged so that no direct rays of light are directed to any adjoining properties. "Dark Sky" compliant lighting designs are preferred.
- g. All development must comply with all regulations and requirements of the Town of Gibbons Land Use Bylaw, the Alberta Safety Codes Act, and all other relevant legislation.
- h. All development located adjacent to a highway shall be required to meet the requirements of Alberta Transportation and shall be referred to Alberta Transportation for a Roadside Development permit in accordance with the Highways Development and Protection Act.

# **Background and Overview**

Section 54 of Edmonton Global's Articles of Association states that: There shall be a mid-year information meeting of the Shareholders held in the Edmonton Metropolitan Region in each year at such place as the Board may specify.

This Mid-Year Meeting is an opportunity for the Edmonton Global Board to provide an in-year update to the Shareholders on impact and outcomes between the Annual General Meetings. The 2022 Annual General Meeting was held on April 21 and next year's Annual General Meeting is currently scheduled to be held on April 20, 2023.

This update includes information for the Shareholders on performance accountability from the period of January 1 through August 31, 2022. Though specific performance measures are not assessed until the end of the calendar year, this report provides an update on some of the metrics, initiatives and activities undertaken by Edmonton Global that relate to performance accountability.

# **Executive Summary**

Edmonton Global operates on Treaty 6 territory and Métis Nation of Alberta Region 4, and as we work to transform our region's economy, we recognize that inclusivity is at the heart of sustainable growth and transformation.

The Edmonton Metropolitan Region is an attractive location for business investment, and between January to August 2022, Edmonton Global closed three final investment decision deals and three prominent conferences with 10-year commitments to be hosted in our region.

The direct impact of these six deals to our region has been estimated at \$58 million and 128 jobs.

Since inception, Edmonton Global has supported 23 successful deals within the Edmonton Metropolitan Region. Collectively, these deals represent approximately \$1.9 billion dollars of capital expenditure and over \$130 million of operational expenditure, bringing the total direct investment into our region to \$2.027 billion. Our labour market is also estimated to benefit from approximately 3000 constructions jobs and 700 operating jobs.



In April 2022, Edmonton Global co-hosted the Canadian Hydrogen Convention and the Nano Canada Conference (now re-branded to Deep Tech Canada), which brought thousands of people and millions of dollars into our regional economy. The third conference, Carbon Capture Canada, is running in September 2022.

We look forward to our inaugural forward/slash Economic Summit on September 28th, 2022. This event is designed to start a movement and bring our region together to unite behind a powerful vision for our economic future.

We continue to strive for organizational excellence and now have a team of 26 staff. Our Strategy and Innovation division has been restructured into the Strategic Partnerships team, led by our new VP of Strategic Partnerships, Sarah Tiet. We have brought on Manisha Arora as our first Director of Trade, who will be leading Edmonton Global in our mandate to increase trade and export.

Edmonton Global is also focused on advocating for our region at the provincial and federal levels of government. In June 2022, Edmonton Global led a delegation of municipal councillors and representatives from academia, industry, and partner organizations in the region to Ottawa to meet with elected officials and senior public servants.

We look forward to continued collaboration and additional successes in the coming months of 2022.


#### International Investment & Trade

#### 2022 Deals in Progress and Announced

As of August 31, 2022, Edmonton Global worked with regional partners to support six final investment decisions in the region, three of which are investment opportunities and three are ten-year commitments of prominent conferences bringing great economic benefit and global awareness of our region.

The direct impact of these six deals to our region has been estimated at \$58 million and 128 jobs.

Since inception, Edmonton Global has supported 23 successful deals within the Edmonton Metropolitan Region. Collectively, these deals represent approximately \$1.9 billion dollars of capital expenditure and over \$130 million of operational expenditure, bringing the total direct investment into our region to \$2.027 billion. Our labour market is also estimated to benefit from approximately 3000 constructions jobs and 700 operating jobs.

In our current opportunity pipeline, there are 10 deals that are nearing completion and are expected to close within the next 6 months. The collective impact of these 10 deals is estimated at \$630 million capital expenditure and \$43.6 million of operating expenditure, for a total investment of \$673.6 million. A total of 425 jobs are also projected to arise from these 10 deals.

The following are highlights of the three final investment decisions made in 2022, as of August 31, 2022.

#### Rane Pharmaceuticals

Edmonton Global reached out to a local contract research organization, Rane Pharmaceuticals, which has been working to develop a proprietary active pharmaceutical ingredient (API) compound specific for treatment of mental health-related maladies using psychedelics.



Edmonton Global helped them secure financing to upgrade quality management systems and to expand operational capabilities in the region. This \$500,000 investment was announced in July 2022. Rane Pharmaceuticals has expressed a strong desire to continue to grow their revenue and clientele with Edmonton Global's support, and as they work to expand their team, we anticipate further investments into the region.

#### Green Transition Holdings - Phase 1

In August 2022, Green Transition Holding announced a \$5 million initial investment into the Edmonton Metropolitan Region, their first investment outside of Europe. Edmonton Global staff introduced the Norwegian company to the region, developed a value proposition, and facilitated engagement with regional stakeholders.

Green Transition Holdings is an industrial and environmental technology company. Their mission is to develop and commercialize innovative technologies that improve the sustainability of industries. They aim to reduce emissions, improve efficiency, and minimize the environmental footprint of industrial and community operations.

Phase 1 entailed opening their first legal subsidiary outside of Europe, Varme Energy Inc., in Edmonton, hiring three local full-time staff and moving one executive from Norway. They recently hired Sean Collins as their CEO. Edmonton Global is continuing to support and engage with Varme as they explore further investments into waste energy projects in the Edmonton Metropolitan Region.

#### Confidential Deal in the Sector of Life Sciences, Healthcare and Biotechnology

Another deal with an Artificial Intelligence-life sciences company was closed during this reporting period with \$500,000 of capital expenditure and 10 operating jobs. Further details remain confidential as of August 31, 2022, but we anticipate being able to share the announcement soon.

#### Canadian Hydrogen Convention

Edmonton Global co-hosted the Canadian Hydrogen Convention alongside TC Energy from April 25th – 27th, 2022. It was highly successful, and DMG events (headquartered in Dubai) committed to hosting the conference in the Edmonton region annually for another nine years (a ten-year commitment in total). Edmonton Global generated strong new leads at the convention.

Explore Edmonton estimates that this conference will bring approximately \$3.5 million of annual impact to our economy for a total of \$35 million over the 10-year period.

The convention was used as the platform for key announcements, such as the:

- Government of Alberta to provide \$50 million to launch a Clean Hydrogen Centre of Excellence
- TC Energy and Nikola Corporation are evaluating a 140-acre hydrogen production hub in Crossfield, AB
- · Edmonton International Airport (EIA) announced several agreements with multi-national and Canadian companies, as well as an investment agency of the Government of Japan, to position the EIA as a significant driver of demand for hydrogen fuel and to support the growth of the Edmonton Region Hydrogen Hub

#### NanoCanada Conference (Re-branded to Deep Tech Canada)



From June 8th – 10th, 2022, the NanoCanada conference was held in the Edmonton Metropolitan Region to explore the convergence of emerging technologies like quantum, nanotech, biotech, and artificial intelligence. International experts spoke at the conference and highlighted the need to collaborate across disciplines to solve our planet's greatest challenges.

Edmonton Global has been an anchor and founding co-host of NanoCanada. We stepped in to help secure external funding, enabling the conference to move forward in 2022. More than 400 attendees joined from around the world, and we have had 300 unique viewers of the livestream videos.

The Edmonton region will host the conference annually for another nine years as part of a ten-year commitment.

#### **Carbon Capture Canada Conference**

Spawning from the success of the Canadian Hydrogen Convention, Carbon Capture Canada (CCC) is the only pan-Canadian national convention showcasing the Edmonton Metropolitan Region's incredible and almost untapped opportunity for carbon capture and underground storage innovation, technology, and destination for global investment. The CCC is Canada's only dedicated Carbon Capture Utilization and Storage (CCUS) convention.

The convention has the support of Canadian trade offices who will be bringing in international delegations, the largest of which is a group of 50+ individuals from Asia. This yearly convention has a year one predicted CapEx of \$1 million.


This conference is taking place from September 20th - 22nd, 2022. The co-hosts are Edmonton Global, Alberta Industrial Heartland Association, and Explore Edmonton. There are currently 500 delegates, 2000 registered attendees, and about 100 exhibitors.

Impact: \$10 million (Estimated \$1 million impact each year for ten years)


#### **Deal Pipeline**

As of August 31, 2022, Edmonton Global was tracking 138 opportunities that could lead to final investment decisions. This is an increase of 166% from this time in 2021 which reflects resumed activities as travel restrictions are lifted from the global pandemic. Of these 148 decisions, 39 are in the decision review or proposal stage. These 39 opportunities represent over \$2.4 billion of potential capital expenditure and over approximately 2017 full time jobs in the Edmonton Metropolitan Region.

#### Global Trade

In the summer of 2022, Edmonton Global hired its first Director of Trade to prioritize trade and export in all sectors for the Edmonton Metropolitan Region. Since then, efforts have been dedicated to Edmonton Export Ecosystem Mapping to gain an understanding of the best approach in supporting companies in the Edmonton Metropolitan Region to succeed internationally.

#### **Export Readiness**

It is understood that a key piece in creating an export-based economy is education. New export readiness programming is underway to make trade accessible for small to medium-sized businesses (SMEs) in the Edmonton Metropolitan Region.

Edmonton Global is a lead applicant for a pending application with Alberta Innovates - Eco System. Development Partnership Program. This initiative would provide a stable support platform for start-ups, scale-ups, and high growth potential ventures looking to conduct business internationally.

Edmonton Global is working to become known as the first stop for companies in the region looking to export.

#### **International Trade Agreements**

Another priority is creating meaningful trade agreements with key partners such as the Importers and Exporters Association of Taipei to remove any barriers in doing business between Taipei and the Edmonton Metropolitan Region.

#### **Trade Events**

Edmonton Global hosts events to support productive trade relationships between the Edmonton Metropolitan Region and other jurisdictions. In August 2022, Edmonton Global co-hosted the High Commissioner for Canada in the United Kingdom and Northern Ireland alongside the Office of the Mayor of the City of Edmonton. The event convened businesses and ecosystem partners in the region to discuss fostering trade relations between the Edmonton region and the United Kingdom. It was well-attended, and the Lieutenant Governor of Alberta participated. We are currently preparing to host delegates from the Brazil Chamber of Commerce in October 2022 to discuss opportunities in Brazil.

# **Investment Readiness & Asset Development**

#### **Economic Development Community Partnership**

Transparent communication and on-demand information is critical in enabling practical collaboration. By ensuring that our economic development partners are proactively aware of our key activities, we are enabling the opportunity for everyone to be well prepared for any engagement and participation in any of our missions.

#### **Regional Sharing Portal**

Our online regional sharing portal (www.edmontonglobal.ca/portal.ca) for the economic development teams in our shareholder municipalities allows each member municipality to track statistics like those above in real time and are customized for their own municipality.

Users can filter data by opportunity stage, lead source, industry, owner, and more. The portal also allows our municipal partners to see what conferences and events Edmonton Global team members are planning on attending, enabling better collaboration and shared travel opportunities.

Edmonton's Global's key activities and travel calendar is planned out as far as possible, with the majority of major events scheduled at least one year in advance. This shared travel calendar enables our economic development partners to also plan out any joint missions in advance of budgeting and resourcing.

To further support our economic development partners, critical and focused information are also now prioritized and summarized in monthly and quarterly reports that are sent to them.

#### Collaborative Deal Flow

Continuous process improvement, with fluid feedback from our economic development partners, has fostered strong collaboration efforts in the community. Once an opportunity advances to the proposal stage and a request for information is required, "Opportunity Calls" are triggered by our team to engage with all our economic development partners. These on-demand calls are nimble and effective in clarifying and assessing what the criteria and requirements are for each opportunity, allowing our municipality shareholders to be selective and competitive in each opportunity.

More detailed funnel development and opportunity progression metrics are continuously being added to our tracking system to foster our growth and development. Learnings from each opportunity, won and lost, will also be analyzed and shared to improve the Edmonton Metropolitan Region's competitiveness and investment readiness.

#### Market the Region

#### forward/slash Economic Summit

Edmonton Global has been busy planning for the inaugural forward/slash Economic Summit to be held on September 28th, 2022. Edmonton Global has pulled together over 40 organizations from government, academia, and economic development to form the steering committee to guide and plan the event. Five working groups have also been formed to plan and activate the programming and showcases that will take place at forward/slash.

The development of this event has been a huge project in pulling our community together to unite behind a common vision for our region, and Edmonton Global looks forward to working together to activate that vision. Working groups, industry panels and other activities are being planned post-event to build on the momentum that is happening and to support the growth of key sectors for our region.

#### Regional Narrative, Chapter Two

In January 2022, we began the work to build out Chapter Two of the regional narrative. Chapter One of the narrative was based on a data-driven approach that determined what international investors are looking for and where the assets of the Edmonton region align. This work determined that talent, opportunity, and innovation are the most attractive assets in our region and helped us form a lens to frame the region. With Chapter Two, we are refining the characteristics and personality of our region by focusing on what makes our region unique, to inform the way we show up in the world in terms of how we communicate and market our region internationally. We are working hard to align and unify our collective voices.

#### **Digital Marketing**

Edmonton Global's new website is under development and scheduled to launch at the end of September 2022. It is designed to capture leads more effectively and increase engagement. The new website is modern-looking and enables custom user journeys. (je. depending on what data is captured on the user. different content on the website will be prioritized for the user's viewing.)

In addition, in this reporting period, Edmonton Global has seen the successful launch of Port Alberta with a brand-new website - PortAlberta.ca. Since its launch, the website has had over 1000 visitors and over 50 submitted enquires. When the new Edmonton Global website is live, it will be integrated with the Port Alberta website to optimize the user experience.

#### Strategic Partnerships

Edmonton Global collaborates with our shareholder municipalities and also with private industry, provincial and federal government officials, Indigenous communities, economic development partners, post-secondary institutions, and others in the region – we all have a role to play in pursuing economic prosperity.

#### **Partnership Events**

#### **Roundtables and CEO Forum**

Edmonton Global hosted a CEO forum in March 2022, which brought together a group of CEOs from some of the largest organizations in the region. Our board chair provided an introduction to Edmonton Global and the transformational opportunities and highlighted the need for collaboration.

In May 2022 following the state of the city address by the City of Edmonton Mayor Amarjeet Sohi, Edmonton Global supported their outreach by hosting two roundtable conversations with business and community leaders on economic development. One roundtable targeted the region's largest employers, and the other targeted leaders in the health and agriculture sectors.

#### **Leduc County Economic Summit**

Edmonton Global was pleased to be invited to participate in Leduc County's Economic Development Summit in May 2022, focused on agriculture. Edmonton Global's Board Director Dr. Stan Blade and staff members Trevor Kloeck and Brianna Morris participated in the program.

#### **RunWithIt Synthetics Model Engagement**

Edmonton Global has been engaged with RunWithIt Synthetics on a synthetic model of the Edmonton Metropolitan Region. In May 2022, we held an event with RunWithIt Synthetics and partner organizations that are participating in the model creation. The event allowed partners to view early stages of the model development and allowed participants to ask key questions. Since then Edmonton Global has worked with RunWithIt Synthetics to engage with regional shareholders on the model development and use cases.

#### **Indigenous Engagement**

We are focused on relationship-building with Indigenous communities and businesses within the Edmonton Metropolitan Region including Alexander First Nation, Enoch First Nation, Paul Band First Nation, Metis Nation of Alberta, as well as other organizations (e.g. Alberta Indigenous Opportunities Corporation) and Indigenous-owned businesses (e.g. Alexander Business Corporation). As part of this initiative, we have participated in Indigenous events including attending Forward Summit - Empowering Indigenous Economies, Workforce Forward (Indigenous Inclusion and Workforce event – June 15th), and Kihciy Askiy – Sacred Land event on June 23rd in the Edmonton River Valley. The Kihciy Askiy area is expected to open in the spring of 2023 and will provide a natural setting for the Indigenous community to host ceremonies, sweat lodges and facilitate intergenerational learning.

#### **Innovation Summit**

We partnered with the City of Edmonton and Innovate Edmonton on an Innovation Summit held on June 23rd with the post-secondary institutions in the Edmonton region. The purpose of the event was to look for ways to collaborate and support the innovation ecosystem in Edmonton and ensure consistent messaging for local and international audiences. We are working with partners on follow-up from this event including the collection of innovation profiles from each of the post-secondary institutions to assist with clarifying key assets and programs offered.

#### **Calgary Stampede Engagements**

Edmonton Global worked together with partner organizations including Invest Alberta, Edmonton International Airport, and Explore Edmonton on planning, hosting and participating in a number of Calgary Stampede events. There were 50+ investors that attended Stampede events along with ecosystem partners, government representatives, post-secondaries, and business community members.

International investors that attend the Calgary Stampede are often attracted there for its publicity but will then inquire about all other opportunities in the Alberta region, so it is critical for Edmonton Global to be at these magnet events and play a leadership role in building awareness and promotion of the Edmonton Metropolitan Region.

#### **Game Discovery Exhibition**

The Edmonton Region famously hosts K-Days each year, attracting people from across the province, country, and globe. This year, Edmonton Global was a proud in-kind sponsor of K-Days' Game Discovery Exhibition, which supports game development in the Edmonton region and celebrates video game culture.

#### **Hydrogen Labour Market Research Project**

The Government of Alberta announced on February 7, 2022, that Edmonton Global received \$75,000 in grant funding through the Industry Workforce Partnerships program for our proposal to study the current capacity and capability of Alberta's workforce to support the emerging hydrogen industry.

NAIT, the University of Alberta, Lethbridge College, MacEwan University, NorQuest College, and the Transition Accelerator partnered with Edmonton Global on the proposal and project. An Industry Advisory Panel was established this year that is being engaged throughout the course of this project:

#### **Regional Database**

Positioning Edmonton Global as the go-to source for investment and trade support includes the leadership of building and maintaining our regional resources and assets database, in collaboration with economic development partners.

As this database continues to mature during our partnership building, we will be tracking the following information:

- · Organizations that are able, ready, and willing to partner with or invest into our foreign investment opportunities, helping to de-risk and induce the final investment decision
- · Organizations with high profile and industry leading facilities and assets that can be leveraged in our regional competitiveness pitch and showcased during in-bound mission tours
- Organizations that are able, ready, and willing to export internationally
- Organizations with international offices that are willing to become ambassadors of Edmonton Global and direct potential investors to us

#### **Ecosystem Collaboration Mapping**

In a stronger effort to establish practical collaboration at the operational level, we have endeavored to start building an Ecosystem Collaboration Mapping which is designed to identify the primary mandates, programs, services, and target audience/customer of each ecosystem partner.

The expected outcome of this initiative is to reduce redundant efforts, increase shared resources and amplify the results of our collective efforts in this ecosystem.

This will be a continuous and collaborative effort with all our economic development partners and major ecosystem partners like Invest Alberta, Explore Edmonton, all Chambers of Commerce, Innovate Edmonton, and the many other organizations.

#### **Regional Competitiveness**

#### **Policy Research Program**

To find out how we can be more globally competitive as a region and attract foreign direct investment, Edmonton Global conducts policy research. Between January and August 2022, we published two papers. one on using incentives to attract investment and one on attracting investment in value-added agriculture. These informed our virtual presentation to shareholders in March 2022.

Edmonton Global policy research informs our advocacy efforts to support Edmonton Global's mandate of attracting foreign direct investment and increasing export and trade.

#### Incentives and Investment Attraction

Attracting foreign direct investment is a highly competitive endeavor. Governments around the world often rely on fiscal incentives such as cash grants, rebates, or tax credits to induce companies to stay, expand, or locate in their jurisdiction.

While we already have the lowest corporate tax rate in the country, incentives can play an important role and be beneficial when best practices are followed, such as:

- The jurisdiction gains a net revenue from the investment after accounting for the cost of the incentive.
- The investment supports local businesses and grows supply chains rather than directly competes with local businesses.
- · The process of awarding the incentive is predictable and transparent, and
- The incentive is awarded in a manner and timeline that ensure the investment is materializing and meeting targets. The full policy paper can be found here.

## **Growing Opportunity in Value-Added Agriculture**

Our region has many advantages that position us well for agricultural investment. However, there is a perception among stakeholders that there are barriers to agricultural investment that are holding the region back from being as successful as it could be.

Some recommendations include:

- · That the Government of Alberta introduce an incentive targeted at bringing in new investments in value-added agriculture. This could take the form of a non-refundable, non-transferable tax credit, whereby if eligibility criteria are met, investors are certain they will receive the incentive award upon the project becoming operational.
- That the Government of Alberta currently very focused on the energy industry – do more to promote and champion the agriculture industry, including a clear commitment to both the animal and plant protein sectors as part of a comprehensive agricultural strategy.

Edmonton Global is regularly engaging with elected officials and public servants in the provincial and federal governments on policy matters and specific investment opportunities.


#### Ottawa Mission, Ontario

#### **Economic Development Matters Podcast**



The Economic Development Matters podcast, co-hosted by Edmonton Global's Brianna Morris and Sherri Bouslama, launched in February 2022. A new episode is published approximately every two weeks.

Through this podcast, Edmonton Global promotes the adoption of a global mindset among regional businesses and stakeholders, serves as a thought leader and resource to partners in delivering on shared economic development objectives, advances pro-investment policies, and promotes positive awareness of the Edmonton Metropolitan Region.

#### Talent Initiatives

To improve the Edmonton Metropolitan Region's regional competitiveness, Edmonton Global is working with post-secondary institutions and other partners in the region to develop a talent strategy. This talent strategy is expected to target various, wide-spread talent and labour issues, including the current significant labour shortage, the ongoing efforts of attraction and retention of highly skilled talent, and the collaboration of talent development between industry and educational institutions.

Specific working groups with our regional partners will be created and facilitated by Edmonton Global.

#### **Youth Talent**

To support ongoing dialogue about youth and talent in the province, Edmonton Global supported a study with the Canada West Foundation on the diversity of job opportunities in Alberta, named Oh, the places youth could go! It was published in June 2022.

#### Global Skills Strategy

In Q4 2021, Edmonton Global signed a Memorandum of Understanding to become an official referral partner for Immigration, Refugees and Citizenship Canada's Global Skills Strategy program and for the Department of Employment and Social Development's Global Talent Stream program.

So far in 2022, we have successfully made two referrals to the Global Talent Stream, as well as identified investors for the Designated Service Channel through the Global Skills Strategy program. We pass on feedback on this program's effectiveness and other concerns around immigration policy and labour shortages to the federal government.

#### **Organizational Excellence**

#### **Board Recruitment**

At Edmonton Global's Annual General Meeting in April 2022, shareholders welcomed five new board members that were identified through an extensive recruitment process. The new appointments are:

#### Personnel

When Edmonton Global welcomed Sarah Tiet as our Vice President of Strategic Partnerships on July 11th, 2022, the Strategy and Innovation team was renamed the Strategic Partnerships team. This team has a refined focus on fostering effective partnerships across the Edmonton Metropolitan Region. Sarah's background is in the private sector as a successful entrepreneur and business owner.

Also on this team, Brianna Morris was promoted to Senior Manager of Policy and Advocacy. Advocacy was added to her title to reflect her refined focus on seeing positive public policy changes implemented and government officials more supportive and engaged on investment files.

Michelle Hiltz joined as the Manager of Strategic Initiatives, and she is focused on supporting effective regional partnerships as well as strategic planning.

Lindsay Milligan joined as Engagement Specialist and is dedicated to Edmonton Global's relationships with the economic development staff in our shareholder municipalities.

In the Trade and Investment team, Brent Jensen was promoted from Director of Business Development to Senior Director of Business Development.

Manisha Arora joined this team as Edmonton Global's first Director of Trade. This position is integral to fulfilling Edmonton Global's mandate of increasing trade and export from the Edmonton Metropolitan Region.

Emily Wang joined this team to support our work on hydrogen.

Madison Côté joined as the Senior Manager of AI and Technology.

Victor Baptista joined as a Research Analyst.

The *Marketing and Communications* team currently has a job posting to bring their core team of three people to four.

Edmonton Global has also benefited from the work of great paid summer interns from different post-secondary institutions in the region.

## **Transformational Impact**

The Shareholders' vision for the Edmonton Metropolitan Region is for "The world to know the Edmonton Metropolitan Region as a top location for investments and to grow a business, and for Edmonton Global to be the go-to organization for landing deals in the region."

There are various degrees of investment opportunities that Edmonton Global activates and supports. Some are smaller in terms of investment dollars and industry impact but may offer greater community-based impact. Others may bring much larger investment dollars and more importantly, trigger radical changes to entire industries and supply chains. While the complexity and intricacy of these transformational deals take much longer to unravel and develop, Edmonton Global remains focused on achieving our vision and long-term goals.

Our primary method of measuring success is the number of Final Investment Decisions into our region, which is typically tracked in terms of the direct benefits from the dollars invested in the initial round of spending and the number of jobs created. Indirect benefits are also seen in the economy from ongoing, business-to-business activity beyond the initial development. Induced benefits are then seen from the increased consumer spending in our communities due to additional jobs and income.

Many of these benefits are distributed throughout the Edmonton Metropolitan Region, regardless of which municipality the opportunity decides to select. While the municipality in which the investment is located typically sees the most benefit, often the jobs created will be held by workers commuting from other municipalities, for example.

#### **Impact Assessment of Air Products**

In June 2021, Air Products announced it will build the world's largest net-zero hydrocarbon facility in the Edmonton Metropolitan Region, totalling about \$1.3 billion in capital expenditures and 2500 construction jobs. Nichols Applied Management Inc. conducted an economic impact analysis of this Edmonton Global deal for the region's 14 municipalities. This analysis included both temporary economic impacts related to facility construction and enduring impacts stemming from ongoing operations and hydrogen production. Key findings are below; the full report is attached.

#### **Economic Impact of Facility Construction**

Initial capital expenditures include wages and salaries paid to construction workers, engineering and environmental services, and the direct purchase of goods and services, such as equipment modules and structural steel elements.

- · Of the \$1.29 billion in capital expenditures, \$656 million (51%) is expected to accrue in the Edmonton Metropolitan Region, and \$350 million (27%) elsewhere in the province.
- · Construction is expected to support \$821 million of labour income (e.g., wages paid to workers) in Canada, with \$476 million (58%) paid to workers in the Edmonton Metropolitan Region and an additional \$190 million (23%) to workers based elsewhere in Alberta

#### **Economic Impact of Ongoing Operations**

The Air Products hydrogen facility is scheduled to become operational in 2024. Although hydrogen production has been established for many years, the uses and market for hydrogen are rapidly expanding. and the economic impacts of this project are subject to uncertainty.

- It is estimated the annual production from the proposed hydrogen complex will support approximately \$1.47 billion in total GDP for Canada, including \$809 million (55%) in the Edmonton Metropolitan Region and \$445 million (30%) elsewhere in Alberta.
- Operations of the facility is expected to support \$456 million of labour income in Canada, including \$168 million (46%) expected to accrue to workers in the Edmonton Metropolitan Region and an additional \$194 million paid to workers located elsewhere in Alberta.

#### **Ecosystem Impacts**

Edmonton Global measures direct impact to our economy in terms of investment dollars and jobs created from deals that we generated or supported. However, we are not able to fully track the direct or indirect impact to our economy from deals generated by other ecosystem players, which may have been generated from our efforts of raising the global profile and competitiveness of the Edmonton Metropolitan Region.

The Edmonton International Airport (EIA/YEG) is a great example of a key player and partner in our ecosystem that reaps significant benefits from all of Edmonton Global's efforts. The Canadian Hydrogen Convention we hosted in April of this year supported 11 MOUs that EIA had been pursuing and are now signed and moving forward to lead on hydrogen development and improved connectivity to our Region with ZeroAvia.

#### **Connectivity is Key**

As the Edmonton Global team is connecting with international site selectors and many investors globally, we often hear that the end of the road in Canada in Toronto. When we bring these groups to tour the region, they are surprised and impressed to see the value and assets that we have to offer the world. The improvement of connectivity to our region will significantly amplify the efforts of Edmonton Global in raising the awareness of our value and assets to the world. Each deal that helps build connectivity is also encouraging the future success of every other deal.

#### **Growth and Expansion Impacts**

As our successful investments land in the region and grow with the industry over time, their impact on our economy continues to expand. The following are some examples of growth and expansion resulting from previously closed deals in our region.

The **Air Products** deal was the start of an iconic lead of the Hydrogen industry for Canada and has now attracted global attention to the Edmonton Metropolitan Region as the global hub of Hydrogen. The initial investment was announced at \$1.3 billion of capital expenditure. The growth of the hydrogen industry and ecosystem has now resulted in them recently **increasing the investment to \$1.6 billion.** 

Alpin Sun is the largest solar farm on any airport land in the world, and we landed that deal in YEG EIA back in 2020. Now, two years later, this deal has spurred many other investments into the EIA for cargo expansion, and played a key role in the federal funding of \$100 million to develop the international cargo hub at EIA.

This solar farm is also key to helping the EIA reach surplus energy and be carbon neutral by 2040.

**Polykar** decided to come to our region in June of 2019, broke ground of their 50,000 square feet, state-of-the-art manufacturing facility in July of 2021, and their grand opening is scheduled for December of 2022. During this journey, they also **donated \$50,000** to the University of Alberta for a new pilot program, supporting the enhancement of professional language and communications skills for the workforce. Not only does this help the University of Alberta, but our regional competitiveness will also improve as a result of our workforce upskilling.

## **Looking Ahead**

The next four months of the year is full of excitement and high potential opportunities.

In our current opportunity pipeline, there are 10 deals that are nearing completion and are expected to close within the next six months. The collective impact of these 10 deals is estimated at \$630 million capital expenditure and \$43.6 million of operating expenditure, for a total investment of \$673.6 million. A total of 425 jobs are also projected to arise from these 10 deals.

Some of the key activities happening in the next four months include:

- · A tour for six international site selectors
- The Carbon Capture Canada Convention (September 20-22)
- forward/slash Economic Summit (September 28)
- Three-five more in-bound investor missions
- 10 12 more international out-bound missions
- · Launch of improved Edmonton Global website
- · Publication of two more policy papers
- · Engagement with new Premier (being selected October 6)

Thank you for your support in building a strong and prosperous regional economy. Bringing new investment dollars into our region is important for economic growth, increasing government revenue and supporting quality jobs and high quality of life for residents. As we look to the remainder of 2022, we excitedly anticipate the successful closing of several more deals.
