Introduction

The purpose of this report is to respectfully request that Council give consideration the Deputy Mayor Appointments for 2024.

According to Council Procedural Bylaw MOG 1/16:

- 1. At the annual organizational meeting, Council shall appoint one member of Council as Deputy Mayor to act as Mayor in the absence or incapacity of the Mayor for a term that is established through resolution.
- 2. Council can by resolution, at a council meeting, make changes to the Deputy Mayor schedule.

Historically, Council has appointed the Deputy Mayor position alphabetically and for a period of 8 months which allows each Council Member to serve as Deputy Mayor for an equal time period over the course of the election term.
